Overview

Nationwide, we have seen an increasing concern for the workforce crisis that encompasses Direct Support Professionals (DSP) and the effects it has on families, like your own. Although the Direct Support profession is one of the highest in demand, in the United States, organizations like Penn-Mar Human Services (PMHS) are not likely to fill these positions due to low wages tied to government reimbursements, limited benefits and lack of career advancement. As such, this has created high turnover and high vacancy rates over the last 30 years.

PMHS has spent the last 40 years, as a steadfast advocate on these issues by creating programs, like the Michael James Pitts Endowment for the Advancement of Direct Support Professionals, ensuring advancement and benefits for our staff, while navigating the ever-changing landscape of governance in the field. Continuing our legacy of good, we seek to provide information and direction to our families, allowing our advocacy leaders to be the innovators within our intellectual and developmental disabilities (IDD) community. Renewing our commitment to advocacy is paramount to the future of those we support and the respect towards the needs and services that are provided to the IDD community.

In its inception, Penn-Mar began with 12 families, today, we have over 600 families and friends that believe in the same mission. We are a collective voice that can create a concerted effort, not only where we see our loved ones in this community, but how we can create equity and inclusion for those with IDD.

The Penn-Mar Advocacy Collective (PMAC) is responsible for supporting the mission of PMHS and the message of our advocacy partners. The goals of the Advocacy Collective are to advance local and statewide legislation, policy and funding to amplify opportunities and experiences for the women and men we support. Members of the committee will be ambassadors of the PMHS mission and will collaborate with the organization.

Focus

- Increase of funding for IDD services that will translate to proper compensation of DSP wages
- Inclusion and equity within the greater community for gainful employment, opportunity and acceptance
- Organization and promotion of IDD Rallies for Pennsylvania and Maryland
