Attending college classes. Working out at a gym. **Shopping. Volunteering.** These activities, small and large, are all ways by which we interact with the community around us. For those supported by Penn-Mar Human Services, meaningful experiences such as these offer an open door to participating in their own communities.

"The idea of community life engagement was largely undefined," says Community Learning Coordinator Mark Rivera-Junkins, who has been with Penn-Mar for five years. "Today it's much more about creating meaningful experiences, allowing for exploration and discovery, expanding our individuals' interests, and encouraging their participation in activities outside of our programs."

Michael Orsulak provides a perfect case study. The "always smiling," "go-with-the-flow," "willing to try anything" son of former Baltimore Oriole Joe Orsulak came to Penn-Mar's Maryland Line Learning Center as a transitioning youth at 21 years of age. Shortly thereafter, he began participating in the Community Learning Services program, which is geared toward community life engagement experiences outside the four walls of a building.

In 2013 CLS was in its pilot phase, with only one group. Today, it's nearly ready to launch its sixth group, and Mark says he expects the program participants to swell from 20 to more than 30 by the end of 2017.

"We're selective in grouping individuals together, because they need to have some common interests and goals," says Mark. "They learn how to compromise when days or activities aren't necessarily their preference. But the power of peer influence is incredible—they're challenged to try new things, and often end up enjoying them."

For example, it was peer influence that encouraged Michael to try his first rollercoaster in spite of his initial hesitation. Now, the rollercoaster is one of his favorite rides.



"Our individuals will time and again exceed our expectations," says Mark. "A part of it is truly the environment that they're placed in."

Whether through more traditionally structured programs like day habilitation at the Maryland Line Learning Center, or through alternative programs like CLS, community life engagement is a theme that runs through many of Penn-Mar's programs.

"Personal Support and Individualized Support Services happen outside of our daily programs, but the focus on community engagement and interaction is just as important," Mark says, noting that these programs also pursue social and recreational goals. "We encourage them to begin making individual decisions about what they want."

Some of Michael's skills have revealed themselves over time, like transplanting seedlings into the ground without hand-over-hand support, or helping out at a Meals on Wheels program, or using a computer without assistance—experiences that encourage active participation in the community.

"Every time you do something for them, you're saying 'I don't trust you to do it," says Mark. "We have an obligation to empower these individuals to do things on their own."

He puts it this way: "We want them to feel empowered to set their own goals and reach their dreams."

Spreading 'Joy and Light'

Through Penn-Mar's Career







When Kas Jasinski wakes up every morning

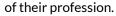
to prepare for her job as a Direct Support Professional, she has one goal in mind. "I want to create a fun, happy, safe place for my guys," she says with a smile. "Every house is like a little family unit, and it's so important to be sensitive to the needs of each family member."

Kas joined Penn-Mar Human Services as a DSP in 2007, after a career that included running a daycare and providing personal support for the elderly and Alzheimer's patients. "It was an easy role to step into, and one where I knew I could help make a difference in others' lives."



DSPs like Kas are the lynchpin in providing stability and security in a group environment, while coordinating activities, preparing meals, and meeting the specific needs of the individuals in their care. It's a job for those with a passion for helping others, one that requires devotion and a heart for service.

Penn-Mar recently partnered with a nationally accredited organization, the National Alliance for Direct Support Professionals, to provide a rigorous three-year credentialing program for select DSPs like Kas. The "Career Ladder Initiative" offers recognition and wage enhancement to DSPs who embrace the knowledge, skills, and values





"I feel honored for the opportunity to be one of the DSPs selected for this program," Kas says. "I love to learn, and I applied for the chance to learn more. I know that everything the selected DSPs will learn through this program will help Penn-Mar



and the individuals it supports, and will help me personally to do the best job possible for my guys."

Her eyes light up when she talks about her "guys," as she affectionately refers to them.

She describes how Robert always loves to sing, dance, and skip around-no matter what else might be occupying her at the time. Jimmy is her "helper," who

always thanks her for the opportunity to tighten a screw or change a lightbulb. Whenever Wayne meets someone new, he loves to talk with them and guess their age. Greg, quiet and observant, demonstrates the value of taking the time to slow down.

In each unique personality, a life lesson reveals itself to Kas. Robert shows how song and dance can fill a house with joy. Jimmy's helpful heart expresses the universal need to feel important and special. Greg encourages Kas to sit still and reflect on life. Wayne prompts her to look a stranger in the eye and ask, "How are you?"



"I just feel truly blessed to do what I do every day," Kas says. "I can't think of a better word to describe it. It's such a blessing to me."

With Penn-Mar's Career Ladder initiative, fervent and spirited DSPs like Kas will receive additional resources to support individuals in experiencing optimal independence and achieving their goals blessing one another as they share in the experiences of life together.



"We have 85 individuals in community jobs."

says Penn-Mar Career Counselor Gary Madigan, discussing the organization's customized employment program. But the variety of employment for the individuals Penn-Mar supports is well beyond what some may imagine. "For example, some individuals work as data entry professionals, dressing room attendants, park maintenance professionals, aides in schools, and daycare attendants."

Gary brings up Julia Dugan, who works at Perform Group, LLC, a dance and gymnastics clothing manufacturer based in York, PA. "She's the bright spot of anyone's day, ecstatic and full of life. She loves being active and having something to do with her hands."

The employment opportunities open to those with intellectual or developmental disabilities have changed dramatically over the last couple of decades. More and more jobs are being created due to a shift in process and philosophy by providers such as Penn-Mar Human Services.

"Customized employment is about so much more than job placement," explains Gary. "Integration into society is a nationwide movement. These individuals want to give back, want to participate, want to be a contributing member of their community. That's what 'transforming life into living' is really all about."



After a two- to threemonth process of exploration and discovery, Gary and other career counselors are able to begin evaluating potential employment opportunities for individuals supported by Penn-Mar like Julia.



"It's great in the trimming warehouse," Julia says. "I like being busy and working more hours. The day goes much faster that way!" She's quick to bring up other "perks" of the job: "Some of the girls are very funny up here. I've made lots of friends."

Larry Scoggin, Director of Operations at Perform Group, has seen the relationships between Julia and her coworkers flourish. "She eats lunch with them every day. There are mothers, sisters, and grandmothers here who all make her feel very much at home."

Working closely with Penn-Mar to place Julia at Perform Group wasn't a difficult decision for Larry to make. "There is a conscious effort to find the right fit, but there was no hesitancy to have conversation on a personal level," he says.

He explains that Julia's job is a value-added position, contributing to her team by doing work that might take managers away from their jobs. She clocks in and out, follows company procedures, and is held to the same standards as her coworkers.

Gary weighs in. "You can take perceived weaknesses and turn them into strengths. Julia is able to develop her skills as she learns and grows as an employee."

"I just learned how to use the threading machine," Julia says excitedly. It's fun—but you have to make sure it doesn't get jammed!"

She pauses. "I'd love to learn even more new stuff. I catch on very, very fast."

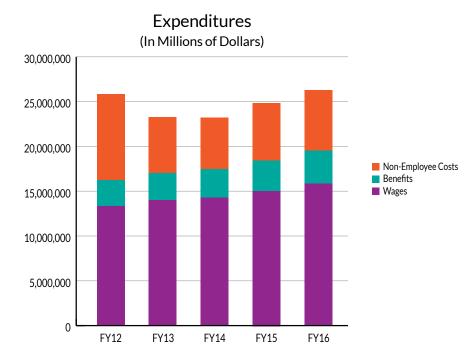

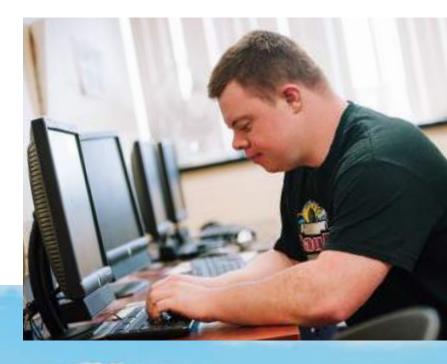
